Consumables bought on Buy-Ups only items that are more than 4 weeks old

A maximum of two artworks large canvases should be rolled up if being stored

Letters, photographs, books, magazines, CDs, Games and DVDs

Personal exercise equipment for example boxing gloves, wraps, skipping ropes, yoga mats

Recreational items for example jigsaws, wooden model kits

Other for example power boards, TV aerials, small personal battery-operated radios, headphones
